Order

Consequent upon the directions of the Hon'ble Supreme Court of India vide its Order dated 16-05-2007 and in persuasion of the All India Council for Technical Education (AICTE), New Delhi vide its notification No. 37-3/legal/AICTE/2009 dated 25-03-2009 ordering strict implementation of Rules & Regulations for prevention and prohibition of Ragging in Technical Institutions, the Anti Ragging Committee &Anti Ragging Squad of the institute is henceforth constituted as under.

The Committee will ensure no incidents of Ragging in the Institute campus including that of Hostel. The incidents of ragging, if any, shall be dealt sternly by the Anti Ragging Committee and action as deemed fit, as per the law of land shall be initiated by the Committee.

It is further notified that the committee will fully study the Rules & Regulations framed by AICTE and make themselves aware about these in to and shall take appropriate measures to prevent the occurrence of ragging as under.

- a. By pasting the Awareness Ragging Posters in the Hostel, Dining Hall, Mess, Gym, Reception, Institute, Library, Class Rooms and Corridors etc.
- b. By counseling of senior students by the committee and other staff.
- c. By taking more care/surveillance.
- d. By putting Anti Ragging Duties round the clock of all the faculty and staff members.

- e. By taking all incidents of ragging very seriously and initiating disciplinary action against defaulter including cancelation of admission and initiating disciplinary proceedings/police action i.e lodging FIR.
- f. By accompanying the students through Anti Ragging Squad from the hostel to the institute and institute to the hostel.
- g. By Strict Vigilance in the Hostel, Mess, Play ground, Library, Canteen, College and Bus by the Anti Ragging Squad.
- h. By guiding the 1st year students appropriately for all works.
- By taking all the other measures mentioned in Regulations framed by AICTE dated 1-07-2009 and dated 25-03-2009 (Available on the site of AICTE).
- j. By obtaining the Affidavit/Undertaking from all students in view of AICTE regulations to prevent the Menance of this social evil of ragging. (This format is available on AICTE website).
